9. Minutes of the meeting held on 16th April 2018

Resolved - The minutes of the meeting held on 16/4/18 were accepted and signed by the chair as a true record.

10. Matters Arising (Not otherwise on the Agenda).

- (a) Commuted Sums query regarding new footpath to Village Hall still outstanding
- (b) Tax on Expenses & Benefits - after the recent correspondence from HMRC, the Clerk has discussed the matter with them. The HMRC think that they can now finalise this so hopefully the Council will receive the completion letter in the near future.

11. Standing Orders

Resolved - Cllr Jolley proposed that the updated Standing Orders are approved and will be implemented at the next meeting. Cllr Richardson seconded. All agreed.

12. Financial Regulations

Resolved - Cllr Harold proposed that the updated Financial Regulations are approved and adopted. Cllr Oliver seconded. All agreed.

13. Humberside Police

PCSO Mike Fowler addressed the Council and reported that there has been a spate of motorbike thefts in the area, as well as attempted burglaries at the sheltered houses & Tokenspire. The former has been a bit unsettling for some of our elderly residents. No major issues, just opportunistic crime. PCSO Fowler advised that during the warm weather people should be extra vigilant and don't leave open doors and windows unattended (including garages).

Cllr Harold asked if the police were still doing school visits. PCSO Fowler replied that planned school visits promoting positive lifestyles are being held in the next few weeks. A resident asked about the camera that had been installed on a lamppost on the A1174 by Coletta & Tyson garden centre entrance; PCSO Fowler said he would investigate. Another resident reported fly tipping on Long Lane; PCSO Fowler advised to ring Street Scene at East Riding Council.

14. Confidential business

Resolved - Cllr Harold proposed that in view of the confidential nature of the business about to be transacted (in respect of selection of supplier(s) for play area refurbishment) it is advisable in the public interest that the press and public be excluded and they are instructed to withdraw. Cllr Beal seconded. All agreed.

15. Play Area Refurbishment

Sara Fletcher gave an overview of the the three preferred designs, highlighting why they had been selected. The council raised a query as to whether the HAGS roundabout could spin in a clockwise direction, the clerk will check.

- (a) **Resolved** - Cllr Beal proposed the following suppliers be selected for the Play Area Refurbishment project. Cllr Jolley seconded. All agreed.
- King Street - Playscheme
 - Southwood Park - Wicksteed
 - Deer Park - HAGS
- (b) **Resolved** - Cllr Harold proposed that minor modifications to the designs should be allowed but without input from local community. Cllr Beal seconded. All agreed. Modifications to discuss with the suppliers include: modifying the roof on the Fairy Tower; an outdoor table tennis table and shelter from the sun at King Street; and an outdoor table tennis table at Southwood Park.
- (c) **Resolved** - Cllr Oliver proposed that final approval of modified designs should be made by agreement between Cllr Harold & the Clerk. Cllr Beal seconded. All agreed.
- (d) **Resolved** - Cllr Harold proposed that Forrest Boyd be appointed to confirm VAT is recoverable for the refurbishment work. Cllr Julie Los seconded. All agreed. A budget of £500 was agreed.
- (e) **Resolved** - Cllr Harold proposed that selected suppliers should be informed subject to VAT status being confirmed and commuted sums grant being awarded. Cllr Beal seconded. All agreed.
- (f) **Resolved** - Cllr Harold proposed that commuted sums applications should be submitted as soon as possible. Cllr Beal seconded. All agreed.
- (g) **Resolved** - Cllr Harold proposed that Paul Harrison at Jane Brook Law be appointed to check contracts prior to Council signing them. Cllr Julie Los seconded. All agreed.

16. Woodmansey Neighbourhood Development Plan

Cllr Oliver reported that that the draft submission papers should be available for the meeting in two weeks time.

The Clerk reported that she had written to Alan Menzies, but has had no response so far. In addition she has spoken to the Planning Inspectorate and Planning Aid; neither can assist Council in this matter. The Council decided to wait for a response from Alan Menzies before taking any other action.

22. Bus shelters

The Clerk reported that she is waiting for confirmation from Carl Gillyon regarding repairs and a date when the shelters will be cleaned.

23. Footpath Scholefield Ave

The Clerk has not progressed this yet - deferred until next month.

24. ERVAS GDPR

Information received from ERVAS on GDPR was **noted**. The Clerk confirmed she is happy for her data to be made available to ERVAS

25. GDPR - Privacy Notices

- (a) **Resolved** - Cllr Julie Los proposed the Council adopt the General Privacy Notice. Cllr Richardson seconded. All agreed.
- (b) **Resolved** - Cllr Julie Los proposed the Council adopt the Privacy Notice for Staff and Councillors. Cllr Richardson seconded. All agreed.

26. Speed monitoring

Cllr Jump reported that a pilot scheme is being trialed in a village on the south of the Humber where residents are using speed camera to record speeding vehicles. The Council asked the Clerk to investigate and find out how to get involved.

27. Play Areas

- (a) Tree felling - The Clerk reported that she is still waiting on Landplan to determine when this work will be done. It is likely it will need to wait until the autumn now.

- (b) Deer Park Way - The Clerk reported that East Riding Council have informed her there is no need to adopt Deer Park prior to doing the refurbishment. Councillor Harold proposed that the Council do not adopt Deer Park at this stage. Cllr Beal seconded. All agreed.
- (c) Monthly reports for March - **resolved**. No items require action.
- (d) Monthly reports for April - **resolved**. The Clerk had investigated repairs to the Spiral Rope Roundabout. Manufacturers wanted the item returned to them. She has contacted Wicksteed to see if they can repair the item and is waiting to hear from them.

Cllr Bowden reported that the power supply appeared to be working fine. The fault is possibly with the battery in the laptop. Cllr Oliver proposed that Cllr Bowden take the laptop to PC World for them to repair. Cllr Harold seconded. All agreed.
